Therefore, you are receiving this to address pressing financial need due to the disruption of campus operations from coronavirus, and pursuant to the authority duly delegated to the Secretary of Education who has stated that she hopes these funds will aid students to stay in school and continue their studies. This authority, comes under the CARES Act and is associated with the coronavirus emergency, as stated in Proclamation 9994 of March 13, 2020, "Declaring a National Emergency Concerning the Novel Coronavirus Disease (COVID-19) Outbreak," (*Federal Register* Vol. 85, No. 53 at 15337-38) and according to the most recent guidance we have received.

How are grants determined? Grants may be used solely for expenses related to the disruption of campus operations due to coronavirus, such as food, housing, course materials, technology, health care, and child-care expenses. Since all students are impacted from a technology perspective, each student, that qualifies (according to the Secretary of Education, students must have completed or been eligible to complete a FAFSA, and meet other criteria specified) is receiving a grant of \$350.
